POLITICAL ATMOSPHERE IN RURAL ECONOMIC DEVELOPMENT IN CITENGAH VILLAGE, SUMEDANG REGENCY

Abstract

Rural economic development is an integral part of national development that is greatly influenced by local political dynamics. This study analyzes the relationship between political atmosphere and economic development in Citengah Village, Sumedang Regency. Using a qualitative approach, this study reveals that local political stability, development policies, and the role of political actors greatly determine the effectiveness of the implementation of village economic programs. The results of the study indicate that politicization of policies, uneven allocation of village funds, and lack of transparency in the management of Village-Owned Enterprises (BUMDes) are the main challenges in economic development in Citengah Village. However, this village also has great opportunities in developing an economy based on local resources, such as the agricultural and agro-tourism sectors. Community empowerment, strengthening the role of the village government, and optimizing BUMDes as an economic driver are the main strategies in realizing inclusive and sustainable development. This study recommends increasing transparency in village governance and synergy between the government, community, and private sector to support rural economic growth.

A. INTRODUCTION

Development is a systematic effort made to improve the quality of life of the community, either through infrastructure development, improving public services, or developing human capacity. In this context, politics plays an important role as the main driver of development. The political atmosphere—which includes stability, policies, and dynamics between actors in the government system—influences all aspects of the development process, from planning, implementation, to evaluation (Smith, 2020).

In a stable political situation, the government tends to focus more on formulating and implementing sustainable development policies. This stability allows for a conducive investment climate, fair distribution of resources, and a sense of security in society (Jones & Davies, 2018). Conversely, political instability often results in hampered development. Conflicts of interest, drastic policy changes, and corruption are some of the negative impacts of an unhealthy political atmosphere (Transparency International, 2022).

This phenomenon is increasingly relevant in developing countries, including Indonesia, where political dynamics greatly influence the effectiveness of development. Differences in political views between key actors often lead to polarization that actually hinders the achievement of common goals (Yusuf, 2019). In addition, in some cases, politics that are too

power-oriented cause inefficient allocation of development budgets, so that strategic programs that should be directly felt by the community are neglected (Rahman et al., 2021).

This participation can be a catalyst to monitor the progress of development and ensure that the policies taken truly reflect public needs (World Bank, 2020). Therefore, a deep understanding of the relationship between the political atmosphere and development is very important, both for policy makers, academics, and the general public.

As the third largest democracy in the world, Indonesia has a dynamic political atmosphere. Changes in leadership, conflicts of interest between parties, and differences in priorities between the central and regional governments are often major challenges in ensuring sustainable development. For example, the implementation of national strategic projects such as the construction of toll road infrastructure, airports, and ports often face obstacles in the form of political interests, which lead to delays or increases in project costs (Setiawan & Hidayat, 2020).

In addition, local political phenomena also affect the implementation of development in Indonesia. One of them is rural development. Regional autonomy which has been implemented since 1999 gives great authority to local governments to manage their regions, but on the other hand, this also opens up space for the politicization of development policies. For example, in some cases, regional heads prioritize short-term populist programs for the sake of political electability, rather than sustainable development programs that take longer to produce results (Iskandar, 2021).

Rural development is an integral part of national development that has a strategic role in strengthening the country's socio-economic resilience. Villages, as the smallest units in the Indonesian government structure, are not only home to most of the population, but also function as centers of economic activity that support the country's economy. One of the interesting villages to study in the context of rural politics and economics is Citengah Village, located in Sumedang Regency, West Java Province.

Citengah Village, with the majority of its population working in the agricultural sector, has abundant natural resource potential, such as agricultural products in the form of rice, vegetables, fruits, and other local products. However, this village, like many other villages in Indonesia, faces major challenges in improving the welfare of its people. One of the main challenges is the uneven distribution of development results which are often influenced by local political factors that do not always reflect the interests of the village community as a whole. This is related to political power at the village level which also influences the allocation of resources, use of village funds, and the development policies implemented.

Since the implementation of regional autonomy through Law No. 22 of 1999 concerning Regional Government, villages in Indonesia, including Citengah Village, have more authority in managing resources including human and financial resources, community empowerment, and governance. Because in implementing policies will be sourced from human resources and other material resources such as finance or budget (Mulyaningsih, 2017).

However, village autonomy, which should have a positive impact on the economic and social development of the community, is often hampered by political dynamics that develop at the local level. The election of Village Heads (Pilkades), for example, can influence the direction of policies implemented in village development, both in village budget allocation and development priorities that prioritize certain groups.

On the other hand, the agricultural sector, which is the mainstay of the Citengah Village economy, faces various challenges, including limited access for farmers to modern agricultural technology, inadequate infrastructure quality, and lack of support for other

Therefore, a study of the interaction between political and economic factors in Citengah Village is very important to understand the dynamics that occur, as well as to find solutions to improve the quality of life of village communities through targeted policies. When local residents participate in planning and implementing development programs, they help ensure that policies reflect actual needs and priorities. In rural villages, active civic engagement also contributes to the emergence of local initiatives that can drive long-term economic improvement (Haryatmoko, 2021).

Victory in the Pilkades often brings political advantages for the winning party, such as greater control over the allocation of village funds and determining development priorities.

One important aspect of political policy in Citengah Village is the management of Village Funds (DD) and the Village Revenue and Expenditure Budget (APBDes). The uneven or non-transparent distribution and allocation of village funds often leads to inequality in the distribution of development. The programs that are implemented more often focus on the development of more visible physical infrastructure, while community-based economic empowerment, such as the development of the MSME sector and village tourism potential, still receive less attention.

In addition, politicization in the management of village policies also has an impact on the management of Village-Owned Enterprises (BUMDes). BUMDes, which should be a tool for empowering the economy of village communities, are often trapped in unhealthy political dynamics. Sometimes, its management focuses more on the interests of certain individuals or groups, instead of prioritizing the economic empowerment of the community as a whole. This has an impact on the less than optimal role of BUMDes in driving the village economy, even though with proper management, BUMDes has great potential to develop various businesses that are beneficial to the community.

Citengah Village Economy: Challenges and Opportunities

The economy of Citengah Village is highly dependent on the agricultural sector, which includes food crops such as rice and vegetable and fruit commodities. However, the agricultural sector in this village faces several significant challenges. Among them is the low access to modern agricultural technology, which hinders the increase in productivity and quality of agricultural products. Inadequate infrastructure, such as damaged roads and limited agricultural storage facilities, are also obstacles for farmers in marketing their products.

In Citengah Village, although there is a BUMDes formed to manage the village's economic potential, it has not been able to function optimally. One of the main factors that hinders the development of BUMDes is the influence of politics in the management of the organization.

Local politics in Citengah Village, as explained earlier, greatly influences the management of BUMDes. In some cases, BUMDes management is more directed towards the interests of certain groups that have political power, so that it does not focus on empowering the wider community. This often leads to inefficiency in fund management and a lack of innovation in running businesses that should be able to drive the village economy.

Furthermore, if BUMDes does not have good and transparent management, then the great potential it has, such as managing local products or providing public facilities, will be neglected. In fact, BUMDes can manage various businesses based on village potential, such as agricultural processing businesses, handicrafts, or even village tourism management that can increase community income. However, in this context, there are opportunities that can be utilized by BUMDes. The development of agricultural-based tourism villages or agrotourism, which has not been optimized in Citengah Village, can be a great potential. BUMDes can be the main manager in developing the village tourism sector, by organizing agricultural-based tourism activities, such as garden tours, fruit picking, or even agricultural training for tourists. Collaboration with the private sector and district government can be the key to realizing this potential.

Potential for Developing Tourism Villages and Their Relationship with BUMDes Potential for Tourism Villages in Citengah Village

Citengah Village has enormous potential to be developed as a tourism village, but so far this potential has not been optimally utilized. This village is located in a fertile area with green rice fields, cool mountain air, and strong local culture. All of these factors can be the main attraction for tourists who want to enjoy the beauty of nature and learn about the lives of farmers and traditional culture.

Several aspects that can be the main attraction in developing tourism villages in Citengah Village include:

- c. Limited Infrastructure and Accessibility: Inadequate infrastructure such as roads to tourist locations, limited accommodation, and inadequate public facilities can reduce the attractiveness of tourists. Investment in infrastructure development must be carried out in a planned manner and involve the community so that it can run well.
- d. Seasonal Dependence: The agricultural sector, which is one of the main attractions of agrotourism in Citengah Village, is highly dependent on the seasons. For example, rice and fruit harvests that only occur at certain times can limit tourism activities throughout the year. Therefore, it is important to diversify tourism activities that can be done throughout the year, such as developing cultural or culinary tourism.

E. CONCLUSION

Citengah Village has great potential to be developed into a tourist village that can improve the local economy, especially through the management of Village-Owned Enterprises (BUMDes). Natural potential such as vast expanses of rice fields, cool mountain air, and rich local culture and traditions are the main attractions that can be utilized to develop the agriculture and culture-based tourism sector.

However, the development of tourist villages in Citengah Village still faces a number of challenges, especially related to the limited human resources skilled in the tourism sector, inadequate infrastructure, and limited marketing. Nevertheless, BUMDes has an important role in managing and promoting this tourist village, starting from providing tourism facilities, developing local products, to empowering village communities through training and job creation.

The active involvement of BUMDes in the tourism sector can be a major driver for sustainable village economic development. Income obtained from the tourism sector will strengthen village resources to finance various development programs, as well as create jobs and new business opportunities for the community. With proper management, Citengah Village has the potential to become a model tourist village that can improve community welfare through local resource-based economic development.

The researcher's suggestions are: Strengthening the Role of Village Government in Economic Decision Making Village government must be more active in formulating economic policies that support the development of the tourism sector in Citengah Village,
